The laws have changed regarding asbestos and they require immediate action. Under Government legislation as at 1 January 2012, all asbestos — both tightly and loosely bonded or friable (previously known as materials and products), are to be classed as "asbestos materials" or "ACM" and recorded in an Asbestos Register.

The danger of doing nothing

Penalties apply to owners who do not abide by the act.

Far more serious however, is the danger asbestos poses to people's health. It is estimated that the number of people diagnosed with asbestos related diseases will not peak until 2020 — by then there will be approximately 13,000 cases of mesothelioma and up to 40,000 cases of asbestos-related lung cancer*.

Are you prepared?

Important: If you own or manage a workplace, you MUST ensure that all asbestos is identified and an Asbestos Register is prepared. If you do not, you are in breach of the Workplace Health and Safety Act and you must have an audit immediately.

When was the building constructed?

Asbestos was widely used as construction and insulation material in buildings until the late 1980s when bans on its manufacture and use were put in place. However, the use of asbestos was only completely prohibited on 31 December 2003, as the bans were not absolute prior to 2003.

However, due to the importing of materials from overseas, it has been identified that even buildings constructed today may contain asbestos.



If you own or manage a workplace, all asbestos must be identified and an asbestos register developed.

Were there any refurbishments or additions to the building?

Any refurbishments or extensions to the original building may have involved the use of asbestos. Even if the original parts of the building did not contain asbestos, it should not be assumed that subsequent additions have no asbestos.
