


Mandatory Fire Licensing Licensing – January 2011 - Every Fire Practitioner must be (BSA) license





Prescribed Documents



Prescribed Documents are set out in legislation and must include the required information Proper Documentation saves money



Qld Legislation

Who is responsible for confirming that a person or company is appropriately Licensed?

Division 3 Obligations of occupiers / Body Corporate

- 54 Maintenance of prescribed fire safety installations
- (1) The occupier of a building **must** ensure that maintenance of each prescribed fire safety installation for the building is carried out by an appropriately qualified person.

Maximum penalty—30 penalty units.

This applies to a Building Occupier / Body Corporate / Building Owner / Strata Management Company

It is necessary that you ensure that your service provider has the technical experience to:


- Inspect and test
- Install and maintain
- Certify that the fire safety installation are compliant each year.

Portable Stream

Scope of works:

- Extinguisher
- Fire Hose Reel
- Fire Hydrant

License Class:

- Install and Maintain
- Certify

Key Changes

- Unpumped Fire Hose Reel only
- Unpumped Hydrant systems 6 monthly only
- Service contractor may no longer be able to conduct the scope work
- Annual and five yearly testing must be performed by a licensed Plumber / sprinkler fitter

Ensure your contractor is appropriately licensed





Passive Stream

Scope of works:

- Fire Doors
- Fire Shutters
- Service Penetration
- Fire Rated Walls and Ceilings
- Fire Rated Joint Sealing
- Fire Dampers

License Classes:

- Certify
 - Install & Maintain Fire Doors and Shutters
 - Install & Maintain: Fire and Smoke Walls and and Fire rated Ceilings
 - Install & Maintain: Fire Collars / Penetration / Fire-Joint Ceiling
- Inspect & Test

Key Changes

- New Install & Maintain: Fire and Smoke Walls and and Fire rated Ceilings
- New Install & Maintain: Fire Collars / Penetration / Fire-Joint Ceiling
- Builders require upskilling by May 2025
- Existing License classes are continued for existing holders
- Classes that became continuing classes of licence cannot be issued or restored after 1 May 2021



Electrical Stream

Scope of Works:

- Fire Detection & Warning System
- Emergency Lighting

License Classes:

- New Design Fire Detection & Warning System
- Install and Maintain Fire Detection & Warning System
 - Includes Inspect & Test
- Inspect & Test Emergency Lighting
- Certify

Key Changes

- Electricians now require to be QBCC licensed to install maintain unless supervised
- Battery operated smoke alarms (class 2 buildings only) no longer fire protection work
- Certify upskilling required May 2025 to include install and maintain
- Electrician must upskill to inspect and test or certify emergency lighting





Water - Based Stream

- Sprinkler System
- Hydrant System
- Water Mist
- Fire Pumps
- Hose Reels

License Classes

- Design
- Install and maintain
- Certify

Key Changes

- New license classes no upskilling required
- Some licenses classes to continue but no longer available

Plumbers must hold endorsements:

- Restricted to domestic & Residential System
- Restricted to Commercial & Industrial System





Special Hazards

Scope of works:

- Gaseous Systems
- Foam Systems
- Chemical System

License Classes

- Install and maintain
- Certify

Key Changes

- Certify upskilling required by May 2023
- Install and Maintain upskilling required by May 2025

Install and Maintain

Ready for use - restore to original operation, alter

Documentation

- Records of Repairs and Maintenance
- Records of Inspect & Test
- Issue Statement about installation compliance

Inspect & Test

Inspect and test - repair or replace

Documentation

- prepare a maintenance record
 - Logbook / Summary Records



Certify License Class

Certify – New Definition

Certify—in relation to fire protection—means:

- prepare a certificate stating that, after carrying out an annual survey of the premises, it is considered no changes have affected the equipment that would cause it not to meet any of its design requirements

- prepare one or more certificates relating to either or both of the following matters:

- the installation of the equipment
- whether the equipment meets its design requirements.

If two or more **certificates** are prepared for an item or system of fire protection equipment: the certificates need not be prepared by the same person.

- *Certificate*—includes a statement and record, however it is called.

- Survey—means a visual inspection of fire protection equipment to identify if the equipment has been altered, damaged or compromised.



Certify License Classes

Certify

- Form 12 Certify install Compliance at the time of built
 - Certificate of Installation Compliance
- Certify Annual Maintenance
 - Annual Survey AS1851
 - Annual Condition Report AS1851
 - Occupier Statement Qld Regulation
 - When done Commercially
- Prescribed Documents must be signed by a person holding the Certify Class
- A Service Contractor without certify licenes can not complete these tasks

Changes to Certify licenses

- Inspection and test work has been removed from the relevant scopes
- Some Contractors and technicians may need to upskill

It is important to ensure that your Fire Service Provider and service technician are appropriately licensed to issue the required documentation





Implications of unlicenced Work

Equipment not correctly maintained

- Equipment may not operate as intended
- Service Records incomplete or not existing

Equipment not correctly serviced

- Equipment failure upon demand
- Equipment life cycle shortened

Safety of the occupants compromised

- The occupant's fire safety relies on all fire safety installations to be operating as per the original intend.


Breach of Legislation


